ADSAI, formerly known as ADI, is a state chartered, not for profit organization founded in 1933 and incorporated in 1937.

The Associated Detectives & Security Agencies of Illinois, Inc. is a not for profit corporation organized for the betterment of the detective and security professions.

This is accomplished through a combined effort of detective and security members to collect and disseminate information vital to our industry.

The Association promotes the general welfare of all licensees and certificate of authority holders statewide and, in doing so, will take proper action in reporting and discouraging violations of the licensing laws.

ADSAI will arbitrate, when asked, disputes among members.

ADSAI regulates fair and ethical practices in our relationships.

ADSAI will introduce and support legislation for the betterment of our industry and will oppose all legislation deemed detrimental to our profession.

ADSAI will support organizations similar to ours throughout the United States.

Membership

Active Membership is open to all licensed Private Detectives, Private Security Contractors and/or those duly authorized representatives of sole proprietorships, partnerships, and corporations who are licensed by the Illinois Department of Financial and Professional Regulation.

Associate Membership is open to those who are management representatives, sole proprietorships, partnerships, firms or corporations that do not qualify for active membership, but who may supply any service or equipment or who are otherwise closely associated with the private detective or security professions.

ADSAI membership currently consists of a cross section of licensed private detective and private security contractor agencies, both large and small, throughout the state.

Objectives

To monitor unfavorable federal, state, county and local legislation and take action to oppose same when necessary.

To foster and maintain good working relations with law enforcement organizations, the media and the business community.

To develop and encourage the practice of high standards of personal and professional conduct among those persons serving in the investigative and security industry.

To discuss and/or execute such other lines of endeavor as the Officers and Board or general membership may deem appropriate.

To maintain cohesiveness within the Association.
